**Note:** So that the title of the paper conforms with your limit of 12 words, the original subtitle ("an outpatient observational study") has now been deleted.

***Response:*** The references all follow the specified format for *World Journal of Gastroenterology*. PMID numbers appear for all references indexed in PubMed, along with DOI citations for those for which this identifier is provided in PubMed.

***Note:*** PMID numbers have not been inserted for references 1 and 2, which are internet references (to World Health Organization websites). Also, PMID numbers were not available for references 8 and 11, which are from journals not indexed by PubMed. For both of these references, the first pages are attached as separate files.

#### **B. Comments from Reviewer No. 01804246**

***Comment:*** This is an interesting study with a large cohort of patients! Minor revision is needed (see in text). The discussion section has to be reformulated, to be more scientific and not only descriptive! The conclusions are too long. See the proposal! [*Conclusion:* Minor revision]

***Response:*** The Discussion section has been shortened by deleting some descriptive statements, thereby improving the ratio of scientific to descriptive text, while still focusing on the key findings of the study and emphasizing the need for improvements to be made to align clinical practice in China more closely with current treatment guidelines for HBV and HCV infections. In addition, the Conclusion has also been shortened by deleting information already adequately stated elsewhere in the text.

#### **C. Comments from Reviewer No. 01799726**

***Comment:*** Spaces should be lies between neighboring words, for example, in the line 4 of

page 5, “conductedfrom August to....” should be “conducted from August to....”. There are many such errs in the manuscript.

**Response: We are uncertain what this comment refers to as the spacing between words had all been checked in the originally submitted manuscript, and errors do not appear in the edited manuscript that was returned to us. Nevertheless, the revised manuscript has been rechecked to ensure that the word spacing is correct and also to eliminate any grammatical inconsistencies.**
