(1) The abstract's grammar is poor with the wrong verb tense used throughout. The next portion of a case report should be the introduction and not a core tip. In the introduction again there is grammar problems that need to be addressed with poor sentence structure and verb tense usage.

We have checked the manuscript carefully and revised the poor sentence structure and wrong verb tense usage.

(2) The case report portion should be as follows: First paragraph: HPI, including pmhx,

surge hx and meds. second paragraph: PE Third paragraph: labs, CT, US findings.

We have revised the case report portion as follows: First paragraph: history of present illness (HPI), Second paragraph: physical examination (PE), Third paragraph: auxiliary examination, Fourth paragraph: operation and histopathologic examination, Fifth paragraph: postoperative recovery.

(3) Do you have the US images because it would be a good image to include in the case report. Once again there is poor grammar throughout this section.

We have provided the US images and revised the poor grammar.

(4) In the discussion should not use the words "we", "us" or "ours". Once again the grammar is poor but the content is very well versed.

We have revised the poor grammar and wrong words such as "we", "us" or "ours". We herein certify that the following manuscript has been edited by native English speaking experts in our group. The edited paper has reached grade A in language evaluation for SCI journals.

(5) Could you comment on how many cases are reported in the literature and if there are only a handful could you represent this in a figure.

We have comment the cases reported in the literature as follows: However, an extensive review of the literature using the PubMed database from 1994 to 2014 found only 18 cases of IPTs originating from the colon[14-29] (Table 1) and only 1 case of colonic IPT causing intussusception[16].

(6) Figure 1 needs to be better cropped to remove all identifiers.

(1) Interesting case Discussion is to extensive, it must be more especif, focus in colon IPT an intussusception. Important describe pathology and frecueny that causes colo-colic intussusception. I woluld like to Know why in this case the intussusception was ileo-cecal when the IPT finded in ascending colon. I'll expect finded colo-colic intussusception.

Operative findings demonstrated a well-circumscribed, firm mass approximately 6 cm in diameter arising from the central ascending colon, intussusception and edema of the appendix. Intussusception was detected in the right abdomen and involved the terminal ileum and cecum and it could not be reset although no bowel necrosis was present. A few pieces of crisp lymph nodes (maximum diameter approximately 1.5 cm) were detected in

the right mesocolon, the roots of the ileocolon and superior colic artery (Figure 3).

The reason of ileo-cecal intussusception may be **due to cecum and ascending colon of inter-peritoneal viscera and ileum of intra-peritoneal viscera in this patient, the tumor in the central ascending colon caused bowel disorders and resulted in ileo-cecal intussusception instead of colo-colic intussusception.**
