2 Revision has been made according to the suggestions of the reviewer 02979409

- (1) *Some language faults are need to be revised. For example: in the abstract, the aim of this study was written as " To compare the efficacy and safety of recombinant streptokinase (rSK) hydrocortisone acetate-based suppositories in acute haemorrhoidal disease", I think that is a tiny fault in expression. Do you mean that rSK versus hydrocortisone acetate-based suppositories ?*

Answer: The word vs. was added in the first sentence of the Abstract to make it have sense. It was a typing error.

(2) *Surgical approaches are usually the standard treatment for Grade III and IV hemorrhoid. In your study, acute hemorrhoids in Grade III and IV were also treated with medicines, although benefits were obtained in this study, how about the recurrences of these treatment? Do these patients need a further treatment?*


Answer: Although surgical approaches are usually the standard treatment for Grade III and IV hemorrhoid, but not always in the acute presentation. Therefore medical treatment was used, for the acute syndrome. This does not exclude surgery for a long term management. Recurrences were not an objective of this study so they cannot be reported. A long term follow-up of these patients is ongoing and will be reported in a further paper.

3 The second paragraph of the Results section was modified in order to provide more details on the course of the trial.

4 References were completed to 30 and typesetting were corrected
