### Plagiarism policy

When *rare instances of plagiarism* (single sentences, 1-2 in total) are found in our client-authors' documents during the editing process, the editor will highlight the passage for easy recognition by the author in the completely edited document and request the author to re-write it in their own words and return it for that single passage to be edited subsequently. However, when *substantial plagiarism* (>3 sentences) is found, the editor will halt all work on the document and immediately return it to the author to address all plagiarized passages before the editing process can continue.

If the author chooses to not rewrite the *substantially plagiarized passages*, then the entire editing fee will be forfeited and the project will be considered completed. If the author chooses to rewrite the passages, we will gladly accept the updated version of the manuscript for completion of the editing process. In this case, the updated manuscript will be returned to the original editor for the continued editing work and the turnaround time will be modified to correspond to the appropriate service type originally contracted by the author.

For *substantially plagiarized passages*, the author will be granted one week to inform *AmEditor* of their decision to rewrite and return the document to continue the editing service. The updated version of the manuscript may be returned at any time within the next two months. It is possible that the quality of the rewritten text will require a more intensive editing type (and corresponding change in service fee) for the modified text only; this potential situation will be assessed on a case-by-case basis.
