(1) The title should not include Acronyms. Please modify it. Thank you!

(2) Please provide the author contributions. Authors must indicate their specific contributions to the published work. This information will be published as a footnote to the paper.

(3) An informative, structured abstracts of no less than 200 words should accompany each manuscript. Abstracts for original contributions should be structured into the following sections. AIM (no more than 20 words): Only the purpose should be included. Please write the aim as the form of "To investigate/study/...;

(4) Methods: It's too short. Please add it to 80 words. Thank you!

(5) Results: It's too short. Please add it to 120 words. Thank you!

(6) Key words: A list of 5–10 keywords should be given below the abstract, each separated by a semicolon (;). Whenever possible, the terms should be from the Medical Subject Headings list of Index Medicus.

This has been done as suggested by the editor.

(7) Core tip: Please write a summary of less than 100 words to outline the most innovative and important arguments and core contents in your paper to attract readers.

This section was added as suggested by the editor.

(7) Results- The description of results should not simply reiterate data that appear in tables and figures and, likewise, the same data should not be displayed in both tables and figures. The results section should be concise and follow a logical sequence. If the paper describes a complex series of experiments, it is permissible to explain the protocol/experimental design before presenting the results. Do not discuss the results or draw any conclusions in this section. This section may be divided into subheadings to assist the reader. Large datasets or other cumbersome data pertinent to the manuscript may be submitted as supplementary information.

Results section has been summarized with subheadings. Table.1 explains the results for all the 8 patients.

(8) Discussion- Do not recapitulate the results, but discuss their significance against the background of existing knowledge, and identify clearly those aspects that are novel. The final paragraph should highlight the main conclusion(s), and provide some indication of the direction future research should take. This section may be divided into subheadings to assist the reader.

Section was subdivided with subheadings. The results discussed here are related to the literature review and are not related to the results discussed in the above section. Indication for direction future research has been added in the conclusion.

Table 5, Figure 3, Figure 4 can be used in supplemental information.
