And after my protest about the charge of payment, they answered :

Dear Dr. Gebicke-Haerter,

Thank you for your prompt reply! But I am a little bit confused about what do you mean by the \$100? Do you mean the \$25 evaluation fee? That is non-refundable but will be applied towards your bill upon acceptance of service, will cover the expert editor assessment and Certificate Service department administrative processing to ensure completeness of required BPG content.

Your paper is written well and only needs our Line Editing Certificate RUSH service. Our Line Editing service includes all the aspects of copy-editing (correction of grammar, spelling, punctuation and style of presentation) along with corrections for word choice, consistency of presentation, and accuracy of topical presentation.
