We are pleased to inform you that your grant request has been selected for funding in the amount of \$50,000.00

The funds will be dispersed as follows:

1. Initial payment of 50% of grant funding will be paid within 30 days of execution of this agreement, or January 6, 2015, whichever is latest and IRB approval obtained (or country equivalent). Please send a copy of the IRB approval letter to Intuitive Surgical. If you feel this protocol is exempt, please send an email or letter from the IRB stating that.
2. The remaining 50% will be dispersed when we received an interim status report approximately half-way through the study period.

Additional paperwork including a W-9 for USA investigators or a W8 of investigators from outside the United States will be required. A final report and accounting for funds will be required at the end of the study period.

If requested follow up information is not provided, investigators, mentors and surgeons from the host institution will be denied future funding through Intuitive Surgical grant program for 2 years. If the money is not used as stated in the grant and/or is not returned to Intuitive Surgical, the applicant will be ineligible for future ISI grant funding.

The purpose of this grant is to promote scientific research, advancement, and/or education in the area of robotic surgical technology.
