26	<p>The 'REFERENCES' section lists the references in the Vancouver style. This style uses Arabic numeral in-text citations based on the order of the first appearance of a source in the text. For citations where no author is indicated, a superscript number should be placed at the end of the sentence. No superscript numbers are used when the reference number is described in the text; for example, "The experimental method used has been described in reference [8]."
