**1. Title:** There was **a minor change in the title.** The word Arab was removed because Turkey and Iran are non Arab countries but are referred to as regional Non-European countries. In addition homozygosity was added to emphasize that majority of our patients were homozygous for disease causing mutations.

## 1. RESPONSES TO REVIEWERS

*We sincerely thank the reviewers and editor for their criticisms and comments. We hereby respond to their queries and present below point by point response to their concerns.*

**This study is well designed, methodology and data collection are competent, the paper is well written in a clear language.**

*We thank the reviewer for his/her positive and constructive comment.*

**I have the following comments:**

- i) **The number of patients on whom genetic analysis was performed is small (36 only) and the authors compared their findings to similar studies in neighboring countries (total more than 500 subjects) so the authors can extend their genotyping work on more patients in Lebanon to reach solid conclusions.**

*We thank the reviewer for this comment. We agree with the reviewer that a larger number of patients is desirable. However, Wilson Disease is rare and the worldwide frequency is 1 in 40000. Hence 36 patients out of 5.8 million Lebanese is quite comparable to 198 patients out of 91.5 million Egyptians or 152 patients out of 31.5 million Saudi Arabians. Regardless of the number in our extensive study, our conclusions were similar to those reported from regional Arab and Non-European countries.*

- ii) **This good study would be suitable for publication at a genetics journal particularly regional ones.**

*Again we thank the reviewer for this recommendation; however we are not aware of any reputable regional genetics journal with good impact. Furthermore, we think our findings are interesting and have impact on Wilson disease management and understanding and that they deserve to be seen and read by international readers. Several population studies from different European countries, the USA, China, Taiwan, and Egypt were published in international journals.*

- iii) **The clinical impact of this study on WD management is limited, therefore many clinicians would not be so interested in this study.**

*We respectfully disagree with the reviewer. Our study has relevance to disease prevention and early detection. Thus, screening of family members of index patients, as well as screening patients with unexplained liver disease might lead to the early detection of WD, and hence early treatment and better outcome. Also, premarital and post-marital education and counseling of people on consanguineous marriage in carriers of WD mutations is of obvious importance.*
