Scientific quality is 1A1D1E, language quality is 1A1C1D. Scientific quality and language quality are not reach to the publication standard of WJT. Reviewer#03655859 pointed out that this manuscript is not well-written, no good statistical analysis was performed (such as matched-control group) due to very small sample size. There is no propensity-matched analysis done to document what you mentioned in your conclusion due to small sample size. Reviewer#00054120 thinks this small sample size could not make some definite recommendations or conclusion. Language need a great deal of polishing. This paper is for the special issue of WJT (invited by the Associate Editor: Frank JMF Dor). Therefore, I suggest the company editor-in-chief allow the authors to resubmit after major revision.</p> <p><b>Company Editor-in-Chief:</b> Based on the reviewers' recommendations, the manuscript will be ACCEPTED WITH MAJOR REVISIONS.
