| | 6c | Relevant history including past interventions and outcomes | <u>8-10/3</u> |
| Physical Exam | 7 | Relevant physical examination findings | <u>18/3</u> |
| Diagnostic Assessment | 8a | Evaluations such as surveys, laboratory testing, imaging, etc. | <u>22/3</u> |
