The topic of enema antibiotic therapy for parasite is in the scope of WJG. Reviewer 02650654 showed that this is a paper interesting general practioners, but need to detail the technique of enema. Reviewer 00506525 pointed out that it is necessary to mention the retention time of the enema that was most effective. The questions raised by the reviewers should be answered. There are 1 figure and 2 tables in the manuscript. Twenty-one references were cited, including one references published in the last three years. No self-citation. 2 Language evaluation: I agree with the comments written by the science editor. There is no any Language editing certificate. 3 Academic norms and rules: I have checked the documents including the conflict-of-interest disclosure form, copyright license agreement, biostatistics review certificate, institutional review board approval, the informed consent statement, and STROBE
