written. Reviewer#03388124 pointed out this manuscript is essentially a literature review on lymph node dissection in hilar cholangiocarcinoma. But the reviewer thinks the preferred format would be either a meta-analysis, or based on the author's own experience. To avoid confusion, HCC is widely used to represent hepatocellular carcinoma, a different abbreviations should be chosen. The authors' conclusion of removing 15 lymph nodes for hilar cholangiocarcinoma appears to be too aggressive. Further justification is desired. Reviewer#03475479 pointed out this review was lacking in novelty but well-summarized. We suggest the authors to add the novelty in this manuscript. There is 1 figure in the manuscript. Thirty-four references were cited, including only two references published in the last three years. The authors need to update the references. No self-citation, we suggest the authors to cite their own research results. 2 Language evaluation: I agree with the comments written by the science editor. 3 Academic norms and rules: I have checked the documents including the conflict-of-interest disclosure form and copyright license agreement, which are qualified. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support.
