Physical Exam	7	Relevant physical examination findings	<u>7</u>
Diagnostic Assessment	8a	Evaluations such as surveys, laboratory testing, imaging, etc.	<u>7-9</u>

	8c	Consider tables or figures linking assessment, diagnoses and interventions	<u>17-19</u>
