The reviewer 03764910 thought the author investigated the association between the onset of delirium and serum IGF-I as well as GH. The results suggest low level of IGF-I is associated with delirium. It would be better if the author could present clinical implication and usefulness of the outcome of this study. The reviewer 02445209 thought that the authors should comprehensively suggest possible avenues for further research in Discussion. There are 1 figure, 2 tables and 55 references cited in the main text. 2. Language quality: A A. 3. Academic norms and rules: "Conflict-of-Interest Disclosure Form" is qualified.
