2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the importance of neutrophil-to-lymphocyte ratio in acute kidney injury diagnosis in the patients gastrointestinal and hepatobiliary surgery. The topic is within the scope of the WJGS.(1) Classification: C and D. (2) Summary of the peer-review report: This manuscript is interesting. Authors showed that NLR at admission is an independent predictor of AKI in patients with</p>	[Y]

gastrointestinal and hepatobiliary surgery. However, The characteristics of surgery should be shown (i.e. emergent, disease). Authors showed that there is no difference in ICU mortality between high and low NLR. Overall survival should be shown to consider the significance of AKI and the number of patients for confirmation conclusion is too small, especially taking into account that this is single center study. The questions raised by the reviewers should be answered. (3) Format: 3 tables and 2 figures. 28 references were cited, including 17 references published in the last 3 years. No self-citation. 2 Language evaluation: 2B. Language editing certificate by AJE was not properly provided. 3 Academic norms and rules: The authors provided the biostatistics review certificate. Not all authors signed the conflict-of-interest disclosure form and copyright license agreement, signatures should be completed. The institutional review board approval form was uploaded. The written informed consent was waived. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (2) Supported by National Nature Science Foundation of China (No. 81770491 to RW); and the Ministry of Education Innovation Team Development Program of China (No. IRT16R57 to YL). (3) The corresponding author has published 2 articles in BPG journals.

Editorial Office Director: Recommend for potential acceptance. 1. Scientific quality: I have checked the comments written by the science editor, and I basically agree with the science editor. The

The reviewer 03475479 stated that NLR at admission is an independent predictor of AKI in patients with gastrointestinal and hepatobiliary surgery, which is interesting. However, the reviewer 02944288 pointed out that the number of patients for confirmation conclusion is too small. The questions raised by the reviewers should be answered. 2. Language quality: 2B.
