superficial non-ampullary duodenal tumors. The topic is within the scope of the WJGO. (1) Classification: B, C and 2D. (2) Summary of the peer-review report: The reviewer#03529755 thought the study did not contain any result about SNDETs patients such as local or distant recurrence, survival. It should be re-written after evaluation of oncologic outcomes of SNDETs to make a conclusion about curation of methods. The reviewer#00503834 thinks this is not a prospective study and the result is useless to endoscope treatment. The reviewer#03251421 thought more details could be shown about the difference of en-bloc/complete resection rate between EMR and ESD. (3) Format: 3 figures and 4 tables. 39 references were cited, including 18 references published in the last three years. 3 self-citations. 2 Language evaluation: 2A and 2B. Language editing certificate was provided by Editage. 3 Academic norms and rules: The authors did not sign the conflict-of-interest disclosure form. The authors signed copyright license agreement. The author provided the Biostatistics Review Certificate, Institutional Review Board Approval Form or Document and Signed Informed Consent Form(s) or Document(s). No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Invited Manuscript. (2) Without financial support. (3) The topic has not been published in the WJGO. (Han Zhang)

Editorial Office Director: 1 Scientific quality: I have checked the comments made by the science editor, and I basically agree with the science editor. The topic of the paper is within the scope of the

WJGO. (1) Classification: Grade B, Grade C, and two Grade D; (2) Summary of the Peer-Review Report: Reviewer 03529755 suggested that it must be re-written after evaluation of oncologic outcomes of SNDETs to make a conclusion about curation of methods. Reviewer 00503834 thought that the lesion was superficial, so ESD was too over. Reviewer 00180958 thought that this study is interesting and dealing with an issue clinically important. Reviewer 03251421 pointed that it would be better if more details could be shown about the difference of en-bloc/complete resection rate between EMR and ESD. The questions raised by the reviewers should be answered; and (3) Format: I have checked the manuscript, and I agree with the science editor. 2 Language evaluation: I agree with the comments made by the science editor. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: I have checked the documents, including the Conflict-of-Interest Disclosure Form, Copyright License Agreement, Biostatistics Review Certificate, Institutional Review Board Approval, and the Informed Consent Statement, all of which are qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for this study. 5 Issues raised: (1) I found the article highlight section is missing. Please write the “article highlights” section at the end of the main text; (2) I found that the figures can’t be edited. Please provide the original figure documents. All submitted figures, including the text contained
