	<p>the design of this study was slightly simpler and the conclusions are rough, so the clinical guidance of this study was not very significant. And reviewer suggested that the authors could establish a model to assess the survival of patients by ultrasound staging, adding clinical staging and ASA scores. Also, the authors need to clarify some questions of reviewer 03011144. At last, the language is poor, and need to be revised carefully.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revision.
