discussed with updated references. The reviewer#03660146 thought the author should add a background to the abstract. The title and tables require editing. (3) Format: 4 Tables. 21 references were cited, including 9 references published in the last three years. No self-citation. 2 Language evaluation: 2A and B. Language editing certificate was provided by AJE. 3 Academic norms and rules: The author provided the Biostatistics Review Certificate, Institutional Review Board Approval Form or Document and Signed Informed Consent Form(s) or Document(s). The authors signed the conflict-of-interest disclosure form and copyright license agreement. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) The topic has not been published in the WJCC. (Han Zhang)

Editorial Office Director: 1 Scientific quality: I have checked the comments made by the science editor, and I basically agree with the science editor. The topic of the paper is within the scope of the WJCC. (1) Classification: Three Grade B; (2) Summary of the Peer-Review Report: Reviewer 03660146 summarized that this manuscript is interesting and well written, abstract should be short, and tables require editing. Reviewer 02857327 summarized that the study is well designed and the manuscript requires a minor editing; and (3) Format: There are 4 tables. A total of 21 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: I agree with the comments

A language editing certificate issued by AJE was provided. 3 Academic norms and rules: I have checked the documents, including the Conflict-of-Interest Disclosure Form, Copyright License Agreement, Biostatistics Review Certificate, Institutional Review Board Approval, and the Informed Consent Statement, all of which are qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for this study. 5 Issues raised: (1) I found the article highlight section is missing. Please write the "article highlights" section at the end of the main text. 6 Recommendation: Conditionally accepted.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Clinical Cases, and the manuscript is conditionally accepted.
