The topic is within the scope of the WJGO. (1) Classification: Grade A, Grade B and Grade B; (2) Summary of the Peer-Review Report: The study aims to</p> | [Y] |

summarize the technique and feasibility of robotic resection of FNH guided by ICG fluorescence imaging. The study design is good with a clear aim. Overall, the manuscript is very well written. Title reflects the main subject of the manuscript. The format of tables should be edited. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 25 references are cited, including 18 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGO. The corresponding author has published 4 articles in the BPG. 5 Issues raised: (1) Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (3) please don’t include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript
