certification. It's clear and well written. Reviewer#03767650 put forward some questions that need to be revised by authors. (3) Format: Two tables and two figures. 23 references were cited, including 10 references published in the last three years. Seven self-citations. 2 Language evaluation: 2A. The authors are British. 3 Academic norms and rules: The authors provided biostatistics review certificate. The authors signed the conflict-of-interest disclosure form. The copyright license agreement was not signed by all the authors in the list. The institutional review board approval form is not eligible. But the author stated that this project was approved by the UK Joint Advisory Group Quality Assurance of Training Working Group, no formal ethics approval was required as the study did not involve patient data. STROBE Statement is not eligible. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) Corresponding author has published one article in WJGE.

**Editorial Office Director:** Recommend for potential acceptance to the WJG. 1. Scientific quality: I have checked the comments written by the science editor, and I basically agree with the science editor. The topic of this manuscript is an observational study of colonoscopy skills course on colonoscopy performance, and it is within the scope of the WJG. The reviewer 00028580 stated that this manuscript is an excellent manuscript from one of the most experienced groups in colonoscopy quality, training and

The authors are from United Kingdom. 3.
