with an abundant sampling, and the topic is very interesting. Intraoperative photographs are explanatory, and tables are exhaustive. The reviewer#00536689 asked the authors to put more information on the surgical technique, and better explain the use of the transanastomotic tube, methods of diagnosis and the definition of anastomotic dehiscence. (3) Format: Six tables and two figures. 46 references were cited, including 11 references published in the last three years. Two self-citations. 2 Language evaluation: A and B. Language editing certificate was provided by the author personally. 3 Academic norms and rules: The authors provided biostatistics review certificate. The authors signed the conflict-of-interest disclosure form and copyright license agreement. The institutional review board approval form, written informed consent and STROBE Statement were uploaded. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Supported by the Medicine and Health Technology Innovation Project of Chinese Academy of Medical Sciences and China Scholarship Council. (3) Corresponding author has published one article in WJG and one article in WJGO.
