The reviewers suggested that explain why endoscopic ultrasound was not performed to acquire tissue for pre-operative diagnosis. And in the discussion a description of the important role that EUS has in this disease when the pancreas is involved. Some references must be added.(3) Format: Four figures. Ten references were cited, including two references published in the last four years. No self-citation. 2. Language quality: 1A and 1B. Edited by Medjaden language editing services. 3. Academic norms and rules: The authors signed the conflict-of-interest disclosure form and copyright license agreement. The written informed consent was provided. The format of CARE checklist is unqualified. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4: Others: Without financial support.
