of the WJG. (1) Classification: 3C. (2) Summary of the peer-review report: Reviewer#01799104 thought the authors should provide authorization of the SEER. Review#00071178 thought the authors divided the patients into two groups, over 65 and under. The authors should explain what criteria they have done. It is best to do this with ROC curve analysis. Is the data in Table-2 related to propensity score matching groups? or is it related to all patients mentioned in Table-1? In other words, if propensity score matching will be used, there is no need for statistics in Table-1. Only descriptive features should be given in Table-1. Reviewer#01557283 thought the present analysis was interesting, but some points should be addressed. All questions mentioned by reviewers should be answered or modified please. (3) Format: 3 tables and 1 figure. 30 references were cited, including 5 references published in the last 3 years. No self-citation. 2 Language evaluation: 3B. Language editing certificate was provided by CureEdit. 3 Academic norms and rules: The biostatistics review certificate was not properly provided. The authors signed the conflict-of-interest disclosure form and copyright license agreement. The institutional review board approval form was uploaded. The written informed consent was waived. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) The corresponding author has not published in BPG journals. (Xiao-Quan Yu)

	<p>Editorial Office Director: Recommend for potential acceptance. 1. Scientific quality: I have checked the comments written by the science editor, and I basically agree with the science editor. The topic of the paper is the colorectal adenocarcinoma, and is within the scope of the WJG. Although the reviewer 01557283 stated that the present analysis was interesting, the reviewer 01799104 and reviewer 00071178 pointed out that some information should put in table 2 and table 1, and the authors should be authorized by the SEER. The questions raised by the reviewers should be answered. 2. Language quality: 3B. The language certificate is provided by CureEdit. 3. Academic norms and rules: I have checked the documents, including biostatistics review certificate, conflict-of-interest disclosure form, signed informed consent form(s) or document(s), and copyright license agreement, all of which are qualified, but the institutional review board approval form or document is not qualified. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in BPG journals.</p> <p>Company Editor-in-Chief: I recommend the manuscript to be published in the World Journal of Clinical Cases.</p>
