2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: Recommend for potential acceptance. 1 Scientific quality: The manuscript is a case report of acute lymphoblastic leukemia in a B-Thalassemia intermedia child. The topic is within the scope of the WJCP. (1) Classification: C and D. (2) Summary of the peer-review report: The reviewer#00506472 thinks this is a well written paper, but the evidences for increased rates of malignancies in B-thalassemia-intermedia patients need to be provided and the</p>	[Y]

relative data on increased rates of malignancies and potential mechanism from the literature should be provided in the discussion. The reviewer#03285337 thinks the hypothesis of iron overload is too speculative and recommends the authors not to discuss about hypothesis but to describe more previous similar report likewise literature reviews. (3) Format: 1 table. 14 references were cited. No reference published in the last three years. No self-citation. 2 Language evaluation: 2B. The authors did not provide the Non-Native Speakers of English Editing Certificate. 3 Academic norms and rules: The authors provided the CARE Checklist-2016. Need authors to provide the original Signed Informed Consent Form(s) or Document(s). The authors signed the conflict-of-interest disclosure form and copyright license agreement. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) The topic has not been published in the WJCP. (Han Zhang)

Editorial Office Director: 1 Scientific quality: I have checked the comments made by the science editor, and I basically agree with the science editor. The topic of the paper is the Acute lymphoblastic leukemia in a B-thalassemia intermedia child, and is within the scope of the WJCP. (1) Classification: Grade C, and Grade D; (2) Summary of the Peer-Review Report: Reviewer#03285337 summarized this manuscript is a well written paper regarding a case report of acute leukemia in a 15-year-old girl with

B-thalassemia-intermedia. However, there is no evidence for increased rate of malignancies in B-thalassemia-intermedia patients was provided. The authors need to provide relative data from the literature in the “Discussion” section and add hydroxyurea as a potential factor for malignancy in B-thalassemia-intermedia patients. Reviewer#00506472 pointed out this case report is nice, and the case itself is very important. However, there are some points need to be addressed in this manuscript. The physicians should think about the occurrence of malignancies. The reviewer recommended the authors don’t discuss about hypothesis but to describe more previous similar report likewise literature reviews; and (3) Format: There is 1 table. A total of 14 references are cited, without references published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: I agree with the comments made by the science editor. The authors have provided a personal language certificate. 3 Academic norms and rules: I have checked the documents, including the Conflict-of-Interest Disclosure Form, Copyright License Agreement, and CARE Checklist–2016 files, all of which are qualified. But the authors need to provide the Informed Consent Statement signed by the patients. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. This study is without financial support. 5 Issues raised: The authors need to re-write the “CASE PRESENTATION” section according to

	<p>the guidelines and format of case report; the authors need to add the PMID and DOI in the reference list. 6 Recommendation: Conditionally accepted.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
