The topic is within the scope of the WJG. (1) Classification: Grade A and Grade B; (2) Summary of the Peer-Review Report: The reviewer#02511983 thinks the</p>	[Y]

manuscript is focused on the investigation of antitumor effects of antibodies against PD-L1 and inhibitor PT1001B in pancreatic cancer, using in vivo studies. The results are interesting and could be useful for other studies. The reviewer#02544751 recommends that the manuscript can be published. (3) Format: There are 5 figures. A total of 37 references are cited, including 17 references published in the last 3 years. There is no self-citation. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form and the Institutional Animal Care and Use Committee Approval Form. The authors signed the Copyright License Agreement. The Conflict-of-Interest Disclosure Form was not signed and the pages or lines of the ARRIVE Guidelines were not provided. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text
