2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective study of the colorectal cancer liver metastases. The topic is within the scope of the WJGO. (1) Classification: Grade A, Grade B and Grade B; (2) Summary of the Peer-Review Report: The manuscript is very well written. This is an interesting study of the predictors of radiofrequency ablation of colorectal cancer liver metastases. The aim of the study is clear, and the methods are clear.</p>	[Y]

Results are reasonable and important. Only the figures are not so clear. Please update the images. And some minor language polishing should be corrected. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 2 figures. A total of 35 references are cited, including 7 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A, Grade B and Grade B. A language editing certificate issued by BioMed was provided.

3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search.

4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China. The topic has not previously been published in the WJGO. The corresponding author has not published articles in the BPG.

5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not
