retrospective cohort study of the vedolizumab for ulcerative colitis. The topic is within the scope of the WJG. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: Reviewer#03261497 thinks it is a nice report with important results. The differences of strategies between the two countries could impact the results, as for instance the use more frequent of immunomodulators in Australia. The authors discussed this aspect and suggested new studies to evaluate this question. The conclusions appropriately summarize the data that this study provided. The authors demonstrated that some of unexplained results justify carrying out new studies, preferably prospective. The reviewer suggests the authors to compare the long-term remission with infliximab. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 3 figures. A total of 24 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The manuscript is from Australia. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the signed Conflict-of-Interest Disclosure Form. The authors need to provide the Copyright License Agreement signed by all authors, the original Institutional Review Board Approval Form, and fill out the STROBE checklist with page numbers. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Takeda

Pharmaceuticals, and the National Institute for Health Research (NIHR) Oxford Biomedical Research Centre (BRC). The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. The first author was born in 1977 (under 45 years old). 5 Issues raised: (1) I found there is no “Author contribution” section. Please provide the author contributions; (5) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (5) The authors need to provide the Copyright License Agreement signed by all authors, the original Institutional Review Board Approval Form, and fill out the STROBE checklist with page numbers. 7
