Please upload language certificate of language editing company. 3 Academic norms and rules: The conflict-of-interest disclosure form and the copyright license agreement was provided. No academic misconduct was found in the Bing search. The highest single-source similarity index is 9%, the repetitive parts should be rephrased. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in WJD. 5 Issues raised: (1) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.(Xiao-Quan Yu)
