2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the EUS-measured muscular thickness and POEM prognosis. The topic is within the scope of the WJG. (1) Classification: Grade A, Grade B and Grade B; (2) Summary of the Peer-Review Report: This study investigated the clinical</p>	[Y]

significance of lower esophageal muscularis propria thickness in achalasia patients. The figures and tables help the readers to make a more understanding of the study. The results were well discussed, but the references should be updated with latest ones. Some minor language polishing should be corrected. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 35 references are cited, including 13 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by Editage was provided.

3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search.

4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China; Natural Science Foundation of Liaoning Province; and Outstanding Scientific Fund of Shengjing Hospital. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG.
