The topic is within the scope of the WJG. (1) Classification: Grade B, Grade B and Grade C; (2) Summary of the Peer-Review Report: Reviewer# 00057983 pointed out the authors have made a good review of this topic. Reviewer# 03026970 thinks this review has certain significance for endoscopic treatment option, thereby</p>	[Y]

decreasing the need for surgical intervention. However, there are still some problems need to be solved. Such as: 1) It is suggested to make a proper discussion on the results and existing problems in discussion; 2) There are three inconsistencies between graphics and text in the article; 3) There are some grammatical errors, spelling errors and punctuation errors in the article. Reviewer# 02953935 pointed the authors investigated meta-analysis for clinical efficacy of the over-the-scope clip device. Although it is well written, several changes are recommended to improve the overall quality of this manuscript. The authors should select only prospective studies and exclude all of the retrospective studies; and (3) Format: There are 4 tables and 6 figures. A total of 107 references are cited, including 33 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A, Grade A and Grade B. This manuscript is from United States. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the PRISMA Checklist Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. This study is without any financial support. The topic has not previously been published in the WJG. The corresponding author has not published any articles in the BPG. 5 Issues raised: (1) I found there is no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the

Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
