Reviewer#03259528 thinks this is a well written article, highlighting EFTR of a duodenal adenoma utilizing OVESCO. However, there are some grammatical errors need to be corrected; and (3) Format: There are 2 figures. A total of 15 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. The authors have provided the language certificate of Springer. 3 Academic norms and rules: The authors signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. Written informed consent and CARE checklist (2016) meet our requirements. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. This study is without any financial support. The topic has not previously been published in the WJGE. The corresponding author has not published articles in the BPG. The first author was born in 1991 (under 45 years old). 5 Issues raised: I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
