This article is about a multivariate predictive model for asymptomatic spontaneous bacterial peritonitis in patients with liver cirrhosis, within the scope of WJG. Summary of peer-review report: The authors defined a predictive model for SBP based on the analysis of clinical features and routine laboratory determinations by a multiple linear stepwise regression model. size of the cohort, this study has particular innovative aspects. The sample size is a limitation of the study design. This is a limitation and should be discussed in a dedicated limitation section. 5 tables and 2 figures. 26 references were cited, including 4 latest references from 2017-2020. No self-citation. 2 Language quality: 2A. Edited by MedE language editing services. 3 Academic norms and rules: Retrospective Study. Copyright license agreement, signed informed consent, IRB, BRC and Conflict-of-Interest statement files are complete and qualified. Bing search and CrossCheck are eligible. 4 Others: With financial support. Corresponding author has not published articles in WJG. Unsolicited manuscript.

Editorial Office Director: Recommend for potential acceptance. 1. Scientific quality: I have checked the comments written by the science editor, and I basically agree with the science editor. The topic of the paper is the liver cirrhosis, and is within the scope of the WJG. The reviewer 02439036 stated that this study has particular innovative aspects. The reviewer 02520738 pointed out that the sample size is a limitation of the study design, which should be discussed in a dedicated limitation section. The questions raised by the reviewers should be answered. 2. Language quality: 2A. The language certificate is provided by MedE Edting Service. 3. Academic norms and rules: I have checked the documents, including biostatistics review certificate, institutional review board approval form or document, informed consent form(s) or document(s), conflict-of-interest disclosure form, and copyright
