The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The reviewer thinks it is a rare and interesting case with good image quality. It would be more helpful to repeat the important radiologic features.</p> | [Y] |

Figure 4 is not significant in patient diagnosis or prognosis. The arrow description is missing in figure 5. Figure 5 and 6 is so zoomed in that the lesion could hardly be seen well. (3) Format: There are 8 figures. A total of 20 references are cited, including 10 references published in the last 3 years. There is no self-citation. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the Signed Informed Consent Form and the CARE Checklist-2016. The authors signed the Conflict-of-Interest Disclosure Form and the Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was without financial support. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-review: Not required. 7 Recommendation: Conditional acceptance. (Han Zhang)
