A total of 38 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The authors are from United States. 3 Academic norms and rules: The authors provided the signed Copyright License Agreement. The Conflict-of-Interest Disclosure Form is not signed, please provide the right format. No academic misconduct was found Bing search, but the CrossCheck detection showed a high similarity to published articles (total 5%). The authors need to rephrase the repeated sentences. 4 Supplementary comments: This is an invited manuscript. The study was supported by 4 NIH grants. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references.
