This article is about mesenchymal stem cell and mesenchymal stem cell-derived extracellular vesicles in rheumatic diseases, within the scope of WJSC. Summary of peer-review report: The manuscript addresses a valuable scientific challenge and the potential of mesenchymal stem cells and mesenchymal stem cell-derived extracellular vesicles for treatment of rheumatic</p>	[Y]

disease. This paper discusses the potential use of MSCs and MSC-EVs in treatment of rheumatic diseases. The subject is interesting and of relevance. 1 table and 1 figure. 123 references were cited, including 40 latest references from 2017-2020. No self-citation. 2 Language quality: 3B. The authors declared that the manuscript was editing by a native English speaker. 3 Academic norms and rules: Systematic Review. Copyright license agreement, PRISMA 2009 Checklist statement, BRC and Conflict-of-Interest statement files are complete and qualified. Bing search and CrossCheck are eligible. 4 Others: With China National Natural Science Foundation financial support. Corresponding author has not published articles in WJSC. Invited manuscript.

Editorial Office Director: 1 Scientific quality: I have checked the comments made by the science editor, and I basically agree with the science editor. The topic of the paper is within the scope of the WJSC. (1) Classification: Two Grade C, and Grade D; (2) Summary of the Peer-Review Report: Reviewer 03810624 summarized that the recent advances, functional roles and mechanisms of MSCs and EVs in rheumatic diseases are discussed in the manuscript, and the work is interesting. Six detailed comments for revising were listed. Reviewer 03549489 summarized that the subject is interesting and of relevance, however, the review repeats much of what has already been published and reviewed surrounding MSCs and more care should be given to link the literature to the disease states mentioned. Reviewer 05085224 summarized that the manuscript

was submitted as a systematic review, however, although the authors submitted the PRISMA checklist, the items of the list are not reflected in the manuscript. The questions raised by the reviewers should be answered; and (3) Format: I have checked the manuscript, and I agree with the science editor. 2 Language evaluation: I agree with the comments made by the science editor. A language editing certificate issued by native English speaker was provided. 3 Academic norms and rules: I have checked the documents, including the Conflict-of-Interest Disclosure Form, Copyright License Agreement, and Biostatistics Review Certificate, all of which are qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. Supported by Chinese National Natural Science Foundation, Shandong Natural Science Foundation, etc. 5 Issues raised: (1) I found the PMID and DOI numbers are missing in some of the references. Please provide the PubMed and DOI numbers to the reference list and list all authors of the references. Please revise throughout; (2) I found that the figures can't be edited. Please provide the original figure documents. All submitted figures, including the text contained within the figures, must be editable. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found that approved grant application form is not submitted. Please upload the approved grant application form(s) or funding agency copy of any approval

	document(s); (4) this manuscript is a review, not a systemic review. Please update the format accordingly. 6 Recommendation: Conditionally accepted. Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted as REVIEW with major revisions.
