information in this area. Reviewer# 02441106 pointed out this is a good paper with interest for practice. The only comment is that is very long. The table in the end is very useful for the readers. Reviewer# 03251421 summarized the authors presented a well-organized and targeted review of management of antiplatelet or anticoagulant therapy in endoscopy. However, the authors need to explain the reason why that they except the POEM. And there are some spelling mistakes in the manuscript; and (3) Format: There are 2 tables and 4 figures. A total of 125 references are cited, including 10 references published in the last 3 years. There are no self-citations. We suggest the authors to cite their own research work. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. The authors have provided the language certificate of professional language company. 3 Academic norms and rules: The authors signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. This study is without any financial support. The topic has not previously been published in the WJGE. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not add the PMID and DOI in the

	<p>reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references.
