discussing the specific role related to different diseases. The novelty of this manuscript is the analysis of extracellular vesicles and their involvement in several aspects of immunomodulation of immune cells. It is necessary a minor revision of the text giving more attention to their importance for different disease. (3) Format: 2 figures. 118 references were cited, including 29 references published in the last three years. No self-citation. 2 Language evaluation: Grade B, B and C. Language editing certificate was not provided, please upload language certificate of language editing company. 3 Academic norms and rules: The conflict-of-interest disclosure form should be provided by corresponding author.
