The topic is within the scope of the WJCC. (1) Classification: Three Grade B; (2) Summary of the Peer-Review Report: The manuscript is well written, and the results are interesting. Reviewer 01524425 required the authors to discussing the limit of the study; and (3) Format: There are 3 tables and 3</p>	[Y]

figures. A total of 15 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and two Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
