This work is a good starting point for the definition of a unique protocol for the classification of these patients. Obviously, other studies are needed. There are some misspellings in the text. 2 tables and 4 figures. 25 references were cited, including 12 latest references from 2017-2020. 1 self-citation article. 2 Language quality: 2B. Edited by Editage language editing services. 3 Academic norms and rules: Retrospective Study. BRC, IRB and signed informed consent files are complete and qualified. Copyright license agreement and Conflict-of-Interest statement files are not qualified. Bing search and CrossCheck are eligible. 4 Others: With National Natural Science Foundation of China financial support. Corresponding author has not published articles in WJG. Invited manuscript.</p> <p><b>Editorial Office Director:</b> Recommend for rejection. I have checked the comments written by the science editor. However, I don't agree with the science editor. #02537773 pointed out that the copyright license agreement and the conflict-of-interest statement files are not qualified. The conclusions are not sufficiently valid as no comparison has been made. #05039425 showed that the manuscript has some misspellings in the text.</p> <p><b>Company Editor-in-Chief:</b> I recommend the manuscript to be published in the World Journal of Clinical Cases.</p>
