throughout eight-week clinical follow-up. The topic is within the scope of the WJP. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: This is a well-performed and written study. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. Reference list is missing. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by a native English speaker was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. No academic misconduct was found in the CrossCheck detection and Bing search. As shown in the CrossCheck report, the similarity of the manuscript is a little high. Some parts of the manuscript should be revised according to the CrossCheck report. 4 Supplementary comments: This is an invited manuscript. The study was supported by Instituto Nacional de Psiquiatría Ramón de la Fuente Muñiz and Secretaria de Ciencia, Tecnología e Innovación. The topic has not previously been published in the WJP. 5 Issues raised: (1) The title is too long, and it should be no more than 12 words; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (4) The authors did not provide original pictures. Please provide the original figure documents.

Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (5) The Reference list is missing. Please add it. And the PMID and DOI numbers should be included into the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references; (6) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (7) Some parts of the manuscript should be revised according to the CrossCheck report. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.

**Editorial Office Director:** I have checked the comments written by the science editor. According to the editorial policy, the total similarity index shown in the CrossCheck report should be no more than 30% and the highest single-source similarity index should be no more than 5%. Please revise the repetitive sentences.

**Company Editor-in-Chief:** I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Psychiatry, and the manuscript is conditionally accepted. I have sent the manuscript to the author(s) for its revision according to the Peer-Review Report, Editorial Office's comments and the Criteria for Manuscript Revision by Authors. The title of the manuscript is too long and must be shortened to meet the requirement of the journal (Title: The title
