The topic is within the scope of the WJSC. (1) Classification: 2B. (2) Summary of the peer-review report: This is an interesting study, with novel information on a relevant biomedical topic. Minor revision is required. The study has been carefully designed and executed.</p>	[Y]

After minor revisions, reviewer suggests this manuscript for the publication. (3) Format: 5 figures. 39 references were cited, including 3 references published in the last 3 years. 3 self-citing articles. 2 Language evaluation: A and B. This article was edited by a native English speaker. 3 Academic norms and rules: The authors provided biostatistics review certificate. The authors signed the conflict-of-interest disclosure form. All authors should sign their signatures in copyright license agreement. The institutional review board approval form was uploaded. The authors declared that no animal was used in this study. The authors should provide the ARRIVE Guidelines with line/page. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in the WJSC.

Editorial Office Director: 1 Scientific quality: I have checked the comments made by the science editor, and I basically agree with the science editor. The topic of the paper is within the scope of the WJSC. (1) Classification: Two Grade B; (2) Summary of the Peer-Review Report: Reviewer 03490943 summarized that this is a very interesting and elegantly conducted study and gave two comments of revising. Reviewer 03712811 summarized that this study has been carefully designed and executed. The experimental observations involve both novelty and potential biomedical implication. And the reviewer gave some detailed comments for

revising. The questions raised by the reviewers should be answered; and (3) Format: I have checked the manuscript, and I agree with the science editor. 2 Language evaluation: I agree with the comments made by the science editor. A language editing certificate issued by a native English speaker was provided. 3 Academic norms and rules: I have checked the documents, including the Conflict-of-Interest Disclosure Form, Copyright License Agreement, Biostatistics Review Certificate, and Institutional Review Board Approval, all of which are qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for this study. 5 Issues raised: (1) I found the key words and core tip section is missing. Please add the key words behind the abstract. Please write the “core tip” section behind of the key words; (2) I found the article highlight section is missing. Please write the “article highlights” section at the end of the main text; (3) I found that the figures can’t be edited. Please provide the original figure documents. All submitted figures, including the text contained within the figures, must be editable. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Recommendation: Conditionally accepted.
