The topic is within the scope of the AIMI. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The author suggested the requirement of multimodal neuroimaging including PET, and the usage of AI methods in reviewing imaging for the final clinical diagnostic. article is well written. The questions raised by the reviewers should be answered; and (3) Format: There is 1 figure. A total of 6 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The authors are native English speakers. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form. All authors should sign the Copyright License Agreement, and the informed consent of treatment should be provided. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the AIMI. 5 Issues raised: (1) The title is too long, and it should be no more than 12 words; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and
