The topic is in the scope of WJG. (1) Classification: 2C and D. (2) Summary of the peer-review report:</p>	[Y]

This review is informative. But, table 2 is too long. This table should be shortened before publication. The result is helpful for clinical practice. Minor revision is required. (3) Format: Two tables and four figures. Fifty-seven references were cited, including five references published in the last three years. No self-citation. 2 Language evaluation: 3B. The author declares that he/she attained a certificate of proficiency in English by Cambridge assessment English. 3 Academic norms and rules: The authors provided biostatistics review certificate and PRISMA 2009 Checklist. The authors signed the conflict-of-interest disclosure form. The authors should sign their signature in copyright license agreement. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) Corresponding author has published one article in WJH.

1. Scientific quality: I have checked the comments written by the science editor, and I don't agree with the science editor. The topic of this manuscript is a systematic review of primary sclerosing cholangitis and autoimmune hepatitis overlap syndrome associated to inflammatory bowel disease, and it is within the scope of the WJCC. The reviewer 00071640 stated that this review is informative, but the table 2 is too long. The reviewer 02460781 pointed out that the result of this manuscript is helpful for clinical practice. The questions raised by the reviewers should be answered. 2.

	<p>Language quality: 3B. The authors don't provide the language certificate. 3. Academic norms and rules: I have checked the documents, including the conflict-of-interest disclosure form, biostatistics review certificate, and PRISMA 2009 Checklist, all of which are qualified. The copyright license agreement is not qualified. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) The corresponding author has published 1 article in BPG journals.</p> <p>Company Editor-in-Chief: As a systematic review article, the manuscript was not written based on the author's own work, precluding its ability to meet the requirements of an invited manuscript for the World Journal of Gastroenterology. Thus, I recommend the manuscript to be published in the World Journal of Clinical Cases.</p>
