The topic is in the scope of WJCC. (1) Classification: 2B. (2) Summary of the peer-review report: The article is interesting and well designed. However, discussion seems too long and has to be shorten, a minor language editing is required. The tables also require an editing. The subtitles in the discussion should be</p>	[Y]

removed. (3) Format: 6 tables. 20 references were cited, including 13 references published in the last three years. No self-citation. 2 Language evaluation: A and B. Language editing certificate by AJE was provided. 3 Academic norms and rules: The authors signed the conflict-of-interest disclosure form and copyright license agreement. The written informed consent was uploaded. The biostatistics review certificate was provided. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in WJCC. 5 Issues raised: (1) Please write the "article highlights" section at the end of the main text. (2) The format of some references seems strange, please reset. 6 Conclusion: potential acceptance. (Xiao-Quan Yu)

**Editorial Office Director:** 1 Scientific quality: I have checked the comments made by the science editor, and I basically agree with the science editor. The topic of the paper is within the scope of the WJCC. (1) Classification: Two Grade B; (2) Summary of the Peer-Review Report: Reviewer 03226068 summarized that the methods are described in detail. The inclusion and exclusion criteria are reasonable and very clear. Results are good, and interesting; Reviewer 03226069 summarized that this study is well designed and the results are very good, discussion should be short; and (3) Format: I have checked the manuscript, and I agree with the science editor. 2 Language evaluation: I agree with the comments made by

A language editing certificate issued by AJE was provided. 3 Academic norms and rules: I have checked the documents, including the Conflict-of-Interest Disclosure Form, Copyright License Agreement, Biostatistics Review Certificate, Institutional Review Board Approval, and the Informed Consent Statement, all of which are qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for this study. 5 Issues raised: (1) I found the abstract is not written according to the guideline of the journal. Please re-write it; (4) I found the core tip section is missing. Please write the “core tip” section behind of the key words; (3) I found the article highlight section is missing. Please write the “article highlights” section at the end of the main text. 6 Recommendation: Conditionally accepted.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Clinical Cases, and the manuscript is conditionally accepted.
