Eighty-two references were cited, including forty references published in the last three years. Nine self-citing articles. 2 Language evaluation: A and B. Language editing certificate was provided by Turacoz Healthcare solutions. 3 Academic norms and rules: The authors signed the conflict-of-interest disclosure form and copyright license agreement. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support (3) Corresponding author has published one article in WJG.

Scientific quality: I have checked the comments written by the science editor, and I basically agree with the science editor.
