(1) Classification: Grade B; (2) Summary of the Peer-Review Report: Reviewer#03766962 summarized that the research objectives achieved by the experiments used in this study, the result can guide clinical practice of peptic ulcer treatment. the key points concisely, clearly and logically. The manuscript cites appropriately the latest, important and authoritative references in the introduction and discussion sections; and (3) Format: There are 3 tables and 3 figures. A total of 41 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by San Francisco Edit was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, informed consent, and STROBE form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Institute of Clinical and Molecular Medicine, The Medical Faculty, Norwegian University of Science and Technology (NTNU), Trondheim, Norway; and the Department of Surgery, Levanger Hospital, Levanger. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) The authors need to provide an editable manuscript of Word format; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange

	<p>the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
