The topic is in the scope of WJG. (1) Classification: B and 2C. (2) Summary of the peer-review report: It is a well written paper. It could be published following minor revision. This manuscript focuses on an interesting</p>	[Y]

topic. This is a good review. (3) Format: Three tables. Sixty-nine references were cited, including seventeen references published in the last three years. No self-citation. 2 Language evaluation: 2A and B. The authors are native English speaker. 3 Academic norms and rules: The authors provided PRISMA 2009 Checklist. The authors signed the conflict-of-interest disclosure form and copyright license agreement. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in WJG.

Editorial Office Director: Recommend for potential acceptance. 1 Scientific quality: I have checked the comments written by the science editor. I basically agree with the science editor. The topic of gastroenteropancreatic neuroendocrine tumours is in the scope of WJG. Reviewer#00506472 pointed out this is a well written paper regarding a systematic literature review of health-related quality of life in gastroenteropancreatic neuroendocrine tumours. The reviewer suggests the author to discuss that how different treatment regimens may impact HRQL parameters. Reviewer#00053420 pointed out this manuscript focuses on an interesting topic and is well-written. However, there are certain major issues to be addressed prior to be considered for publication. In the title, reviewer strongly suggests the authors to focus exclusively on pharmacological intervention studies excluding cross-sectional data and the study of the psychotherapeutic

intervention based on SCT. In the method section, the authors should present in more detail their search strategy and provide a relevant flow diagram. Results should not be presented study by study but should be classified and integrated in order to provide more solid and useful information. Reviewer# 03732555 pointed out this is a good review. However, the HRQoL assessment part is so long and tedious, the authors should simplify it. And the author should explain the difference among the assessments. There are 3 tables in the manuscript. Sixty-nine references were cited, including seventeen references published in the last three years. No self-citation, we suggest the authors to cite their own research results. 2 Language evaluation: I agree with the comments written by the science editor. 3 Academic norms and rules: I have checked the documents including the conflict-of-interest disclosure form, copyright license agreement, biostatistics review certificate and PRISMA checklist file, which are qualified. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support.
