A total of 38 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade 2A. A language editing certificate issued by Filipodia Publishing was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and the Institutional Review Board Approval Form. The author still needs to provide the Biostatistics Review Certificate, the STROBE Statement, the Signed Informed Consent Form(s) or Document(s). The signature in the Copyright License Agreement provided by the author is incomplete. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by the Dutch research council (NWO) project. The topic has not previously been published in the WJG. 5 Issues raised: (5) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (6) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (7) I found the PMID and DOI in the reference list are not complete.
