tumor entity of sarcomatoid HCC. Reviewer recommend to accept this paper as it is. It is a good work with a rare histological subtype.

(3) Format: Four tables and four figures. Thirty-one references were cited, including ten references published in the last three years. No self-citation. 2 Language evaluation: A and B. Language editing certificate was provided by AJE. 3 Academic norms and rules: The authors provided biostatistics review certificate. The authors signed the conflict-of-interest disclosure form and copyright license agreement. The institutional review board approval form was uploaded. The authors declared that the analysis used anonymous clinical data that were obtained after each patient agreed to treatment by written. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Supported by two National Natural Science Foundation of China (General Program). (3) Corresponding author has published one article in WJG.
